

2. The duties and functions of the Committee as per section 166 of the Electricity Act; 2003 are as under:-

- (a) To coordinate and review the extension of electrification in each district.
- (b) To review the quality of Power Supply and consumer satisfaction.
- (c) To promote energy efficiency and its conservation.

3. Frequency and Quorum for meetings:-

The District Coordination Committee shall meet at least once in every 3 (three) months. The quorum for the meetings of the Committee shall be 5 (five) members including the Chairman.


