- (ii) To facilitate connectivity to the grid for the generating companies and the open access to the transmission system.
- (iii) To facilitate smooth and reliable operation of the electricity grid at inter-state level.
- (iv) To deliberate and evolve consensus on any other aspect of the development of Power System as referred to the Forum by the Central Govt.
